Participation in this Study

This study was completed by a team of three U.S. firms – Cimarron Capital Partners LLC, PCG International LLC, and Millennia Consulting LLC – with legal tax advice from the Mexican law firm Ortiz, Sosa, Ysuzi. Payments to Mexican subcontractors were less than twenty percent of the total grant amount. The remainder was paid to U.S. domiciled firms and U.S. citizens. All air travel between the U.S. and Mexico was done on U.S. airlines.

Investments in Venture Capital Resulting from Implementation of Study Recommendations

The Mexican Investment Catalyst Fund is planning to invest about \$250 million over the next five years. To the extent that the Fund directs those investments effectively and in line with international best practices, as suggested in this study, these investments could create a multiplier effect that would generate millions of dollars of additional investment into venture capital and private equity funds in Mexico. U.S. based funds as well as U.S. investors who invest in funds that invest in Mexico could potentially participate in the industry in Mexico. In addition, U.S. service providers such as law firms and accountants would be available to supply services needed for venture investment transactions in Mexico.
